MINUTES

1. Call to Order:

Director Atkins submitted a voucher for \$300 that includes time spent on the plant re-start and running for parts. Director Atkins also submitted a millage voucher for January and February for \$244.40. Director Mayne submitted a millage voucher for January and February for \$336.00. Director White submitted a voucher for \$300 that includes the plant re-start and working with Roto Rooter to repair the broken sewer line. Director White made a motion to pay all of the reimbursements. Director Ardoin seconded the motion. All voted yes and the motion passed.

8. Open Discussion:

Director White said when Roto Rooter was out they reported a lot of tree roots in our line behind Bill Hayes house. This line will need replacing or we will experience more clogs in the future.
